### [OFFICIAL EMBLEM OF THE RUSSIAN FEDERATION]

#### **PRESIDENTIAL DECREE**

### On the Interim Administration of Certain Assets

In light of the necessity to take immediate measures in response to unfriendly and contravening the international law actions of the United States of America and associated foreign states and international organizations aimed at unlawful deprivation of property rights of the Russian Federation, Russian legal entities and individuals and (or) limitation of their ownership rights, in order to protect national interests of the Russian Federation and in accordance with Federal Laws dated 30 December 2006 No. 281-FZ "On Special Economic Measures and Enforcement Actions", No. 390-FZ dated December 28, 2010 "On Security" and No. 127-FZ dated June 4, 2018 "On measures of influence (counteraction) to unfriendly actions of the United States of America and other foreign states", I hereby declare:

- 1 To establish that, in case the Russian Federation and/or Russian legal entities or individuals are deprived of their ownership of the property located in the territories of foreign states that commit unfriendly acts (hereinafter referred to as "unfriendly foreign states") against the Russian Federation, Russian legal entities or individuals, and (or) property rights, or the said rights are being limited, or in case of a threat of such deprivation or limitation, threat to national, economic, energy or other types of national security or to the defence capability of the Russian Federation, the Interim Administration is established over:
  - (A) movable and immovable property, located in the territory of the Russian Federation, belonging to foreign persons associated with unfriendly foreign states (including foreign persons that are citizens or residents of these states, or the place of their registration, the place of their predominant economic activity, or the place of preferential extraction of profits from activities is located in these states), and persons who are controlled by the aforementioned foreign persons (hereinafter - persons of unfriendly foreign states);
  - (B) securities and participatory interests in authorised capitals of Russian legal entities owned by persons of unfriendly foreign states;
  - (C) property rights belonging to persons of unfriendly foreign states.
- 2 To approve the attached list of movable and immovable property, securities, participatory interests in authorised (share) capital of Russian legal entities and property rights over which the Interim Administration is established.
- 3 To appoint the Federal Agency for State Property Management ("**Rosimushchestvo**") as the institution performing functions of the interim administrator.
- 4 The President of the Russian Federation, including upon the proposal of the Federal Agency for State Property Management, may designate another institution as the interim administrator.
- 5 Interim administrator shall exercise the powers of the owner of movable and immovable property, securities, participatory interests in the authorised (share) capital of a Russian legal entity, property rights (hereinafter jointly - the property) which are under Interim Administration, except for the powers to dispose of the property.
- 6 The interim administrator shall perform the functions of conducting an inventory of the property

under Interim Administration and providing for the safekeeping of such property.

- 7 The costs associated with the Interim Administration of the property are financed from the income from its use.
- 8 Interim Administration can only be terminated by a relevant act of the President of the Russian Federation.
- 9 This Decree comes into force on the date of its official publication.
